3. Unless otherwise noted, this proposal does not include corrections of any code and/or City/County ordinance violations that exist on the subject property. Any violations that are discovered before, during and/or after our work has been completed; the cost of correcting same shall be charged as an extra to this proposal.
4. Unless otherwise noted on this proposal, only the permit fee is included. Any additional data such as but not limited to heat gain, duct, energy, wind load, tie down calculations, etc., or any additional /extra installation items the governing municipality requires to be done that is not included in our proposal will be charged as an extra.
5. It is understood and agreed that title to the equipment, parts and materials, whether installed or not, are to remain in the name of **QUALITY AIR CONDITIONING COMPANY, INC.** until all sums due us have been paid for in full, including all costs of collection, and customer hereby grants **QUALITY AIR CONDITIONING COMPANY, INC.** right of access to the equipment, parts and materials **QUALITY AIR CONDITIONING COMPANY, INC.** name for all purposes, including the removal of same if not paid for by customer. Possessor rights shall remain with **QUALITY AIR CONDITIONING COMPANY, INC.** and we shall have the right to transfer any and all notes held hereunder, and the title or right of possession will pass to the legal holder or transferee.
6. In the event any collection efforts of any sums due hereunder, purchaser agrees to pay all of said collection costs, including but not limited to court costs and Attorney's fees, in and out of court and if court at all levels.
7. Interest will be paid to the seller at the rate of 1-1/2% per month of the unpaid balance on delinquent accounts.

10. If existing materials will be removed or replaced, same will become our property unless specifically agreed otherwise in writing.
