Dear Dorin,

Thank you for your message and clarification regarding the window pricing. Please feel free to send over my specific contract for records purposes.

Regarding your request to access my unit for interior inspection:
Due to the ongoing legal and regulatory complaints—some of which involve Austro Construction, S&D Engineering, and members of the Omega Villas Board—I do **not consent** to any interior access to my property by Austro Construction or any representative associated with this project at this time.

I have already taken detailed video and photo documentation of the current interior conditions of my unit, which are time-stamped and preserved in the event of any future dispute or liability claim. This documentation will be used to verify any potential changes or damages after construction begins.

With regard to your request that I withdraw my complaint filed with the Department of Business and Professional Regulation (DBPR), I respectfully decline.

As you yourself noted, Austro Construction is acting **under the direction of the Board and S&D Engineering**. My complaint was submitted in my role as both a **homeowner**

and a **Board Member**, based on my firsthand experiences, documented evidence of damages, and the pattern of issues reported by multiple residents in the community. I have every right to pursue proper state-level oversight on behalf of the Association and its residents.

I trust you will continue your work in a professional manner, and I will continue to protect my rights as a property owner and fiduciary representative of this community.
