


Our Sentricon Subterranean Termite program which includes green stations (see below) were installed around the perimeter of all the buildings in Omega Villas. It is normal to see the round green cap flush with the ground (see below). These stations will not interfere with any landscaping that is done on property. The stations contain a termite bait inside which is called Noviflumuron, which is a **100% Green** product and it will **NOT** harm any people or pets. With Florida weather (rain and extreme heat), sometimes the landscaping shifts and changes, a station may slightly raise from the ground. If this does happen, it is important that you **DO NOT** pull the station out or stomp on it to put back in place. Do not remove or open the green Sentricon stations under any circumstances. If you find a station that has broken, been tampered with or has shifted, please contact Your Management Services which will then contact Beach environmental for inspection and re-install service*. For the first year Beach will inspect every 3 months. After the first year, Beach will inspect annually, when the Sentricon Program is renewed. Paying the yearly renewal after year 1, you can extend the warranty period year after year. Our Sentricon Subterranean Termite program creates a barrier around your buildings and will provide 24/7 protection from Subterranean Termites. Thank you for being a valued Beach Environmental customer.



*If stations are vandalized or if multiple stations are removed and missing, there will be a fee charged to replace and re-install.

I, as an individual and or/we, as a company, hire We Care Animal Removal Inc. to capture wildlife and or cats from our property at the above address. If/we have read and understand this form. Please check all boxes below that will apply.

1. **DUCKS and CHICKENS**

For hand capturing the price is \$45 per duck and/or chicken with a one-time \$125 trip fee. All ducks/chickens are brought to a farm in Homestead.

For shooting animals with a high-powered airsoft rifle, there will be a one-time \$125 trip fee and \$25 per duck and/or chicken.

NOTE: — IF WE ARRIVE AND NO DUCKS OR CHICKENS ARE ON SITE THERE WILL BE A \$100 SERVICE CHARGE

2. **WILDLIFE with no cat trapping**

(Two nights of cage trapping/ 3 days in all. **(Raccoons, Opossums, Iguanas, Toads, Fox, Tegus etc.)** For the trapping service it'll be \$185.00 for the set up fee. The tiered price structure is \$95 each for animals removed and relocated,

DISCOUNT: If we remove 25 to 50 animals within **one day** of capture -The price becomes a flat \$45 each-deleting the tiered price altogether.

EXTRA DISCOUNT occurs if 51+ animals are captured in **one day**- the price is lowered to a flat \$40 each with no scaling prices. — Over 100 animals per DAY price will be discussed per job situation.

3. **TNR cats with the county (Sterilize and Return).** *If wildlife is caught, check box 4 for removal.*
(2 nights of trapping/ 3 days in all) Fees are the GRAND TOTAL of cats caught within TWO nights of trapping with a 1 time **\$185.00 set up fee** in addition to an amount of **\$95 for each cat caught**. We'll trap, transport them to MD Animal Services. The county facility reserves the right to adopt, so you may not get some cats back (this is a very rare event). All are sterilized and ear tipped with a rabies vaccination. We'll pick up the cats from the facility and return them back to you. *Some cats do not survive surgery and may die shortly after due to complications. When trapping; we sometimes catch non-target cats and wildlife that you may not want removed, a \$25 release fee will apply when we release where caught. If you would like the animal relocated, a \$95 fee per animal will apply (see box 4). READ the information in the yellow box on Page 2.*

4. **WILDLIFE while cat trapping** *Yes, I want all wildlife removed off my property, if caught.*
(Raccoons, Ducks, Opossums, Chickens, Iguanas, Toads, Fox etc)

Check this box if you want wildlife removed while we are cat trapping.
The wildlife is **\$95** each animal removed and relocated.

A) Cats with collars will be released where caught, unless indicated otherwise.
B) A release fee of \$25 each will apply for any type of wildlife and cats when the client doesn't want them removed from their property. C) A cost of \$250 for each trap will apply if any are stolen or damaged, in addition to the cage tampering fee of \$150.
D) Any animals caught that are deliberately released or any human interference to our cages such as moving them or closing them, you/ your company will be charged a tampering fee of \$150 in addition to the fees for any damages and or stolen cage fee. The job will be stopped. If this occurs while we have already caught and removed animals, you will be charged for what animals were removed in addition to the above penalties. Note: Any released animals by anyone other than our company, you will be charged full price for that animal(s) at the scaling prices. If you believe people will be releasing the animals and tampering with our cages, we strongly encourage you to provide a security guard during the trapping event.

Any repercussions that may result from performing the duties hired will be the sole responsibility of the above client's name and/or signer, and in no way will affect or burden We Care Animal Removal and/or its employees and/or subcontractors. This waiver includes any legal fees or responsibilities that may result for the above mentioned. Upon signing this contract, I/We agree on the price to proceed with the job. Any legal fees pertaining to court costs and attorney's fees will be the responsibility of the client, as an individual, and/or as a company for We Care Animal Removal to collect payment. In addition, we reserve the right to place a mechanics lien on any company or personal property for collection of payment. The highest interest rate allowable in Florida will apply to any outstanding bills.

Note: All native wildlife is relocated unharmed unless injured or very sick. Relocation is overridden by the county and or State if a health alert is issued. Ducks and chickens are taken to a farm.

A \$50 Charge per night applies, if trapping is unsuccessful. (Does not apply when cages are tampered with) -----ALL INVOICES MUST BE PAID ON FINAL DAY OF TRAPPING-----

****Note: We CANNOT guarantee that we'll catch every animal on your property. Some animals are leery of cages/nets. When this occurs, we recommend that we attempt another session in about three weeks. Each time we re-start trapping, the price per animal will scale as if it were a new job.





