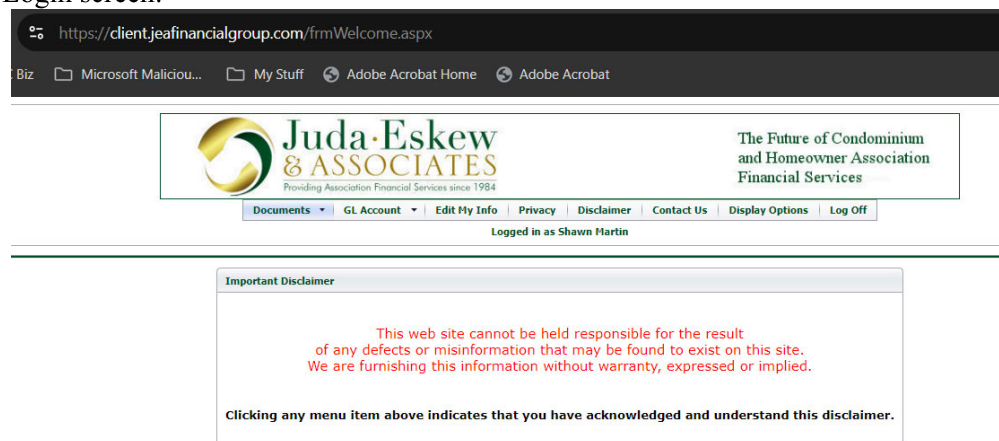

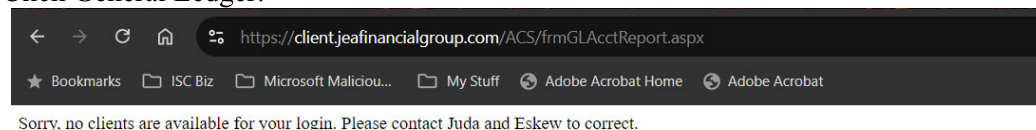
Oh, lastly, as you are probably aware (I am sure I circulated the Juda Eskew complaint) that I still don't have access to the Juda Eskew portal which appears to be in direct violation of the new 7/1/24 laws that COA/HOA resources can't be withheld retaliatory against any unit owner especially a whistleblower. I would guess that all other Board Members still retain access to those online records. Guess what, I am still blocked from the Juda Eskew portal even after I complained to the DBPR which is now going to the General Counsel of the DBPR for further investigation and I have recorded video footage of me addressing both Carol Eskew and the Board (especially Patty Sabates) in the below video footage asking about why General Ledger Accountant notes per transaction were removed and my access to the online Juda Eskew General Ledger was revoked, as displayed below.

Now, I used to have access for which I believe I was blocked when I ran reports and confronted the Board about my suspicions on the numbers. So, again, what is going on here?

Again, we are all 128 of us paying for services that appear to be being used against the community, especially me the resident whistleblower! Further, I have repeated over and over that I was the whistleblower, unit owner and board member, yet I keep having what appears to be retaliatory actions taken against me (see below) even after the 7/1/24 Florida Condo Association laws were passed!

I believe this the below video footage is in direct support of a future Broward County court case of my direct rights being violated which I even state to the two Police Officers with Patty observing:

Notice: in nearly every video you will see a Police Officer who Patty claims is there to keep the peace, when in reality one needs to ask for proof of when any violence ever erupted in the past say 5 years at any Omega Villas Board meeting. This is easy to determine by requesting the City of Plantation police reports to be ran for our Board Meeting address or community over the past 5 years.

This 2+ hour video is where I confront Juda Eskew on my findings regarding being blocked from the online records that I was given access to including ALL other Board Members:

Eskew mid-year budget review summary: lowered budget from \$1000 and up in maintenance fees down to \$500 or more monthly -- very convenient given all the heat that was on this Board before I joined it in April 2024 (given also that I was discussing a recall in November of 2023 based on all the issues I found -- full documentation and support on this statement) These matters has also been filed in multiple DBPR complaints to the City of Plantation PD, FBI, and FTC which some appear to be still under investigation. I have records of those transactions as well if the proper authorities need copies?

So, why was my access revoked when other Board Member VOLUNTEERS' access wasn't??? This was included in a DBPR investigation which is now under the General Counsel Office's legal team's review among other findings to suspicions.

We are facing \$6-8 million in restoration fees to the City of Plantation fines and liens, so why are legal fees such an issue as they appear to be the main subject matter of this meeting -- reiterated how many times and by which Board Members?, OR could it maybe possibly be more examples of whistleblower retaliation?
