This letter is to inform you that we are in receipt of your correspondence requesting access to public records under Chapter 119, Florida Statutes. Specifically, you are requesting to view or to obtain copies of the complete file.

If you wish to obtain copies of the material you have requested, there will be charges associated with this request as authorized under Chapter 119, Florida Statutes.

1. One sided photocopies- \$0.15 per page
2. Two sided photocopies- \$0.20 per page
3. If the volume of the information requested requires the extensive use of professional, and/or clerical, and / or supervisory assistance, a special service charge will apply. The statutory fees associated with this special service charge are as follows: \$26.24 per hour for clerical assistance. After the first thirty (30) minutes of review, this special service charge, as authorized by statute, will apply. Effective January 1, 2014, we will require a fair and substantial upfront deposit on all voluminous requests that require extensive clerical assistance. This deposit will be required before commencing work on these requests. Please be advised that the hourly fee mentioned above will apply to this request. A deposit of **\$104.96** (4-hour x \$26.24 = 104.96) by check or money order should be made payable to the State of Florida. If you are unable to provide a check or money order for the amount due, you can provide payment in the form of cash. We only accept cash in the exact amount requested. There will be no charge for the first 30 minutes of time. This deposit will cover the first 4 1/2 hours of clerical time dedicated to preparing the complete file. This deposit will be required to continue processing your request. As noted previously, your deposit is based upon a preliminary and conservative estimate. You will be charged for the actual time expended in reviewing and redacting the complete file. **Additional deposits may be required at a later time.**
