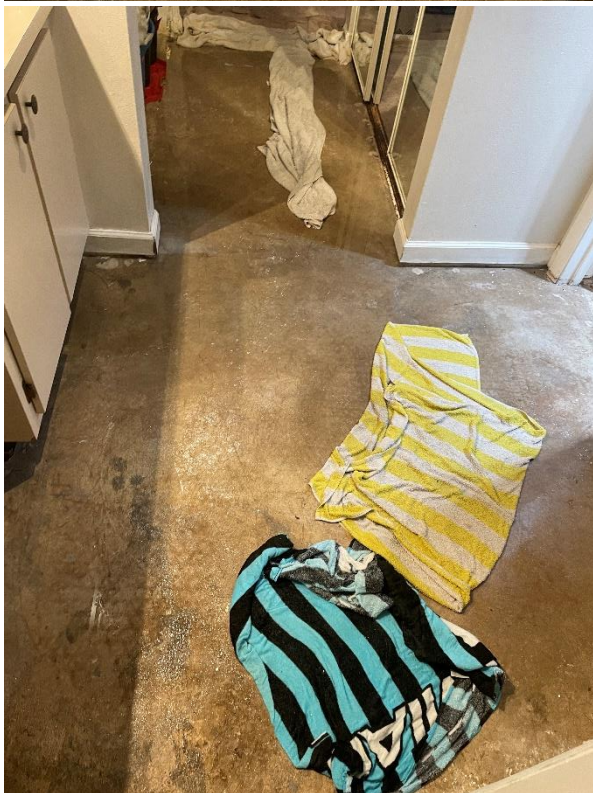
**MYSTERIOUS CUTS TO SHAWN MARTIN'S ROOF LOCATED AT 1760 NW 73
AVE., PLANTATION, FL 33313. THESE CUTS WERE LOCATED BY
EMERGENCY ROOFING CONTRACTORS AROUND FEBRUARY OF 2024 THAT
SHAWN MARTIN HIRED BECAUSE OF THE EXTENSIVE WATER DAMAGE
FROM THE LEAKING ROOF AND BECAUSE THE BOARD OF OFFICERS AND
DIRECTORS AT OMEGA VILLAS WOULDN'T DO THE EMERGENCY REPAIRS
EVEN AFTER THE LAWSUIT WAS SETTLED BACK IN JULY OF 2023. THE
ROOFERS STATED THAT THEY WERE STRAIGHT CUTS LIKE DONE WITH A
BOX CUTTER OR KNIFE.**

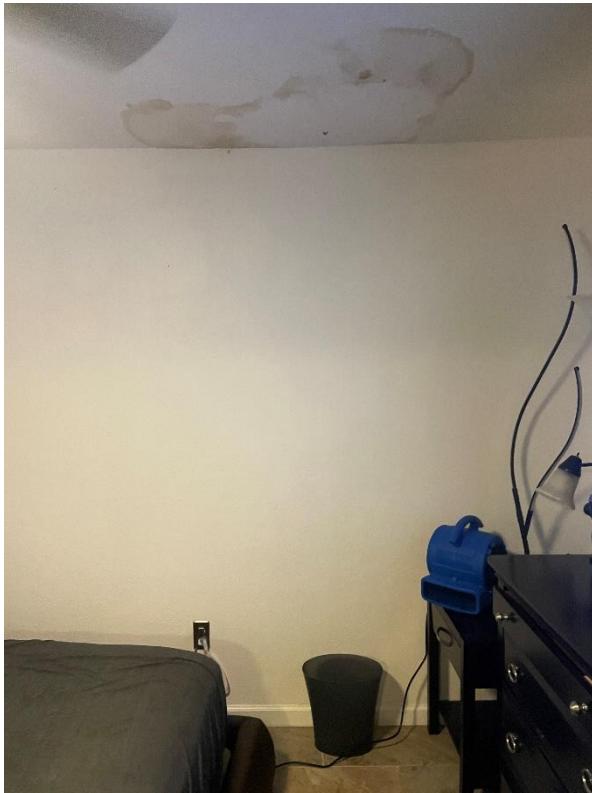
